Explanation of the Declaration Ultimate Beneficiary/Beneficiaries (UBO)

Why are we requesting you to complete this Declaration Ultimate Beneficiary/Beneficiaries)?

This is a statement used to indicate the identity of the Ultimate Beneficiaries within your organisation.

This request is made pursuant to the 1977 Sanctions Act and other sanction regulations, aiming to prevent us remitting funds to persons deemed active in money laundering or financing of terrorism.

This is why we need to know which Ultimate Beneficiaries may dispose of the funds within your organisation. These funds includes the amounts we transfer. Without this declaration, we are unable to send any funds to your organisation, including, for example, a claim pay-out.

Ultimate Beneficiaries own or control at least 25% of the organisation.

According to the 1977 Sanctions Act, everyone financially involved in any transaction or financial service completed or provided by us is a relation or a stakeholder. UBO is often defined as 'owner' or 'title holder'. This is generally correct, but not complete. Only persons owning or controlling at least 25% of the organisation are classed as an Ultimate Beneficiary.

There are direct and indirect Ultimate Beneficiaries.

An UBO is a beneficiary natural person, directly or indirectly holding a 25% interest or higher share in the organisation (i.e. its assets). For example a direct interest in shares or certificates. Indirect stakeholders are persons owning or controlling 25% or more of:

- the voting rights in the General Meeting;
- an interest as the beneficiary of the capital;
- a special form of control of the capital;
- a right to a share in the community;
- a right to a share in the profit;
- the voting rights in the decision-making process on changing the partnership contract;
- the voting rights in the decision-making process on key decisions relating to the execution of the partnership contract;
- actual control.

Perhaps other organisations have rights or control in your organisation. The Ultimate Beneficiary of your organisation may be a natural person with direct control in the other organisation and indirect control in your organisation.

Example: company X has a 50% share in your company. Natural person Y is a 50% shareholder of X. This also means he/she has a 25% indirect right in your organisation and is therefore classed as an Ultimate Beneficiary of your organisation.

What are sanctions?

Sanctions are political instruments in the foreign policy and security policy of the United Nations and the European Union. These are instruments deployed in response to infringements on international rights or human rights, or to force change to policy after non-compliance with legal or democratic principles.

Sanctions also form a key weapon in combating terrorism. Freezing the funds of terrorists will not completely disable preparations for terrorist attacks. But it will make things that much harder. The most prevalent sanctions are:

- weapon embargoes and trade restrictions;
- travel and visa restrictions;
- financial sanctions that can be classed into two categories:
- an order for freezing funds;
- a prohibition or restrictions on providing financial services.
